## **Robbery Detectives Arrest Suspect In String Of Armed Robberies**

The City of Miami Police Department's Robbery Unit has arrested Travion Collie (DOB: 08/23/2002) in connection with a series of armed robberies that took place on March 20, 2025.

The incidents began in the early morning hours of March 20<sup>th</sup>, when officers responded to an armed robbery at N.W. 6<sup>th</sup> Avenue & N.W. 8<sup>th</sup> Street. The victim was held at gunpoint, and both his cell phone and wallet were taken. Approximately 20 minutes later, a separate armed robbery occurred at N.W. 1<sup>st</sup> Avenue & N.W. 23<sup>rd</sup> Street. During this incident, two female victims were also held at gunpoint and robbed of their purses.

Robbery detectives promptly responded to both scenes and launched an investigation. The detectives were able to recover the first victim's cell phone, which was processed by Crime Scene Investigators for forensic analysis.

On March 24, 2025, Robbery Detectives responded to N.W. 2<sup>nd</sup> Avenue & N.W. 25<sup>th</sup> Street to investigate another armed robbery. The victim, a rideshare driver, was robbed at gunpoint for his belongings while providing a ride to the suspect. Shortly after the incident, patrol officers located and apprehended Mr. Collie. At the time of his arrest, he was in possession of a firearm and the victim's property.

Further investigation, including forensic evidence collected by Crime Scene Investigators, confirmed that Mr. Collie was the suspect responsible for the robberies that occurred on March 20, 2025.

The successful apprehension of this violent offender is the result of the diligent investigative efforts and tireless commitment of the City of Miami Police Department's Robbery Detectives and Patrol Officers. Mr. Collie is currently in custody, facing multiple charges related to these armed robberies.
